PROMOTER

CONDITIONS OF ENTRY

3. The promotional period will commence 05:00pm Thursday 30 September 2021 and closes 9:00am Monday 8 November 2021.
4. This promotion is in no way sponsored, endorsed, or administered by, or associated with, Instagram or Facebook.

WHO MAY ENTER

5. Entry is open to all Australian residents aged 18 and over.
6. Employees or contractors of the Promoter or its associated companies or agencies, or any suppliers of prizes, or the immediate family of such persons, are not eligible to enter this promotion.
